What is AWO?

The American Waterways Operators (AWO) is the national trade association for the domestic waterborne transportation industry, representing the interests of member companies operating on the inland and coastal waterways and harbors of the United States.

AWO's fundamental purpose is to represent the domestic tugboat, towboat and barge industry before the federal government. It also acts as the industry spokesman to the media and represents member company interests on state and regional issues.

What is Affiliate Membership?

Affiliate Members are associations, corporations, sole proprietorships, partnerships, and individuals sharing common interests with AWO's carrier members but not eligible for AWO carrier membership. **Affiliate Members** enjoy the full range of benefits of AWO membership. However, **Affiliate Members** neither vote nor hold office in AWO. There is one **Affiliate Member** seat on the Board of Directors that is filled annually through nomination by the AWO Chairman of the Board, and election by the AWO Executive Committee.

Cost of Affiliate Membership

Affiliate members pay dues on an annual basis. If your company has subsidiaries, sister companies, or branch offices that elect to hold separate membership in AWO and exercise individual membership privilege, they will be termed **Affiliate Associate Members**, and will pay a separate fee.

Affiliate Member Dues:

For Corporate Businesses or Partnerships:	\$4,000.00 Annually
For Sole Proprietors	\$1,350.00 Annually
For Affiliate Associate Members**	\$ 540.00 Annually

***Affiliate Members* paying \$4,000.00 may add separate Memberships for subsidiaries, sister companies, or branch offices. The fee for each Affiliate Associate Member is \$540.00 annually.

Contributions or gifts to AWO are not tax deductible as charitable contributions. However, they may be tax deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of association lobbying activities. AWO will notify you annually of the non-deductible portion of your dues — the part which is allocable to lobbying.
