## American Waterways Operators Elects Chairman: David Sehrt Calls for Member Commitment and Engagement

ARLINGTON, VA — The members of the American Waterways Operators, the national trade association representing the tugboat, towboat and barge industry, elected a new slate of leaders during AWO's Spring Convention held recently in Washington, D.C.

David G. Sehrt, Senior Vice President and Chief Engineering Officer of Ingram Barge Company, was elected Chairman. James F. Farley, President of Kirby Offshore Marine, LLC, was elected Vice Chairman. Mr. Sehrt succeeds outgoing Chairman Frank Morton, Director, Turn Services LLC.

AWO President & CEO Tom Allegretti praised Mr. Morton's leadership over the last year, stating that, "AWO has been blessed with leaders of great insight and vision. Frank effectively led the organization through a year of momentous change and even greater successes."

Mr. Sehrt added that he "stood in awe" of the hours Mr. Morton had voluntarily devoted and the miles he had traveled during his time as Chairman. Mr. Sehrt then called upon AWO members to follow Mr. Morton's example of active commitment and engagement. "This will be my theme for the year," Mr. Sehrt stated.

"One of the things these visits have reinforced for me is how much we can accomplish by bringing together the diverse interests and strengths of AWO members," Mr. Sehrt stated.

"Pick an issue or two that interests you and commit to getting involved. Make this the year that you commit to strengthening our industry. Join a working group. Make a grassroots visit. Host a towboat or tugboat tour. Submit comments on a proposed rule," Mr. Sehrt stated. "If each of us does that, I am confident that the return on our investment will be a long and meaningful record of organizational accomplishments and greater value for each of our companies as well."

Mr. Sehrt will serve at AWO's Chairman until April 2016.
