

Stakeholder Requests for Hosted Mobile Enrollment Sites Procedures and Requirements

The following are the Lockheed Martin requirements for hosting a temporary mobile/portable enrollment capability. The purpose of this capability is to enroll members of stakeholder organizations (employees, unions, associations, etc.) and to provide them with the added convenience of avoiding individual trips to a fixed enrollment center for enrollment.

Volunteering for Hosted Mobile Enrollment

- For more specific information regarding who to contact to volunteer to host a mobile enrollment location, please see the list of Facility Coordinators in the Appendix or the Overall Deployment Point of Contact. Your inquiry will be directed to the appropriate Field Coordinator.
- Lockheed Martin's Field Coordinators will attempt to make contact with each facility point of contact to gather additional information regarding their inquiry within 10 business days.
- Once that contact has been established, the LM field Coordinator will make an initial
 assessment regarding the ability to meet the request. Ultimately, each request will be
 assessed on its individual merits, taking into consideration all factors including
 available resources and scheduling constraints.
- It is Lockheed Martin's desire to be able to address each inquiry within 10 business days after the field coordinator makes initial contact with the prospective site with a determination of suitability to host a mobile enrollment site.

Minimum Enrollment Requirements and Pre-Enrollment

- Volunteering to be a mobile enrollment site provides stakeholders with an opportunity to have an onsite enrollment capability for the exclusive use by their employees or members. Because of this degree of exclusivity, stakeholders who desire to be considered as a mobile enrollment site will need to meet the following criteria:
 - o In order to maximize the usage of each individual mobile enrollment station, it will be necessary to work closely with individual stakeholders. Generally, a single mobile enrollment workstation can process 25 enrollments per day, and will require approximately one day preceding the start of a mobile deployment to set up, be configured, and establish connectivity with the secure site at Annapolis Junction, MD. In order to ensure maximum usage, Lockheed Martin will limit deployments to those stakeholders who can guarantee a minimum of two days of enrollment activities at a steady pace of operations. Lockheed Martin cannot guarantee stakeholders that mobile enrollment stations will be available on the preferred dates, but will work with stakeholders to identify mutually agreeable dates based on resource constraints and stakeholder preferences.
 - Pre-enrollment of all individuals prior to the mobile enrollment station arriving on site is strongly encouraged in order to "right-size" Lockheed Martin's support, assure adequate staffing and facility layout, and to minimize enrollment time;



- Stakeholders who are scheduled for a mobile enrollment deployment will be required to manage a schedule for their employees to ensure the enrollment station is fully utilized in order to maximize productivity.
- A schedule of enrollees will be provided to the Lockheed Martin representative 5 days prior to initial enrollment in order to plan for appropriate staffing.
- While the individual mobile enrollment timeframe will be dependent on the size of stakeholder's enrollment population, on average it is anticipated that an individual mobile enrollment station will be capable of enrolling 25 individuals per eight-hour day.
- For consideration for mobile enrollments to take place, the requirements listed below must be met. LM will coordinate timing and schedule of mobile enrollments with the stakeholder based on mobile availability and customer availability. Meeting the requirements listed does not guarantee having a mobile enrollment capability established at any stakeholder's facility. Lockheed Martin will do everything possible to meet all requests; however Lockheed Martin reserves the right to prioritize or decline specific mobile deployments based on each site's unique circumstances.

Card Issuance/Activation

• During the period that mobile enrollments are being conducted at a stakeholder's site, Lockheed Martin will arrange to bring those cards that are ready for activation back to the stakeholder's site on a weekly basis. The specific day of the week will be coordinated between the stakeholder and the Lockheed Martin agent. Following the scheduled mobile deployment period, Lockheed Martin will make arrangements for one return trip to the mobile enrollment location for remote issuance and activation of credentials. This visit will be scheduled approximately 10-45 days following the completion of mobile enrollment for that site, depending upon the number of cards ready for issuance and availability of resources. A minimum of five business days' notice will be provided prior to returning for issuance and activation. If applicants can not be available on the day(s) issuance and activation are scheduled, or their cards have not yet been returned for issuance, they will be provided with information on the nearest fixed enrollment center where their card may be picked up.

Contractual Requirements

• A contractual relationship with Lockheed Martin is not required and no compensation will be provided by Lockheed Martin.

Payment

- Individual payments may be accepted via all approved methods (e.g., Credit Card Master Card or Visa; Money Orders, Cashier's Checks, Pre-Paid Debit Card). Check and Money Orders are to be made payable to "Lockheed Martin".
- Bulk payments for enrollments may be done with a corporate check as a single payment and will be based on the anticipated number of enrollments at the facility. Unless otherwise arranged in advance with the Field Coordinator, the stakeholder is required to provide payment in full for their enrollees at the start of enrollments and will be required to provide a listing of individuals to be enrolled. As individuals are



enrolled, they will be marked off on the list and a daily tally will be reconciled at the close of business each day. At the conclusion of the mobile deployment period, a final reconciliation will be conducted between the Lockheed Martin representative and the stakeholder. If a refund is required, it will be processed at that time for payment via check to the stakeholder in accordance with Lockheed Martin's financial processes.

Required Facilities, Equipment and Infrastructure

- Trusted Agents and any necessary materials/enrollment equipment will be provided by Lockheed Martin.
- The stakeholder must provide a closed door office or offices with the following physical requirements:
 - The stakeholder will be required to provide a high speed broadband internet connection and a DHCP address to support each mobile enrollment station that will be installed. Additionally, the stakeholder will, if necessary, be required to provide a tunnel through any network firewalls.
 - o Provide a non-Internet telephone system
- Since this is a stakeholder facility it is assumed that stakeholders will provide for their employees or membership the following:
 - Queuing space for waiting enrollees
 - Adequate vehicle parking area
 - Heating/Air Conditioning
 - o Restroom Facilities
 - o If possible provide handicapped accessible entrances
